- (1) Family and friends celebrated Paul's 80th birthday, March 17 at Medici's Restaurant in Normal with a breakfast buffet. Paul was a patient at BroMenn at the time, so family members gowned and masked up at the hospital (after our meal) to sing and share birthday cake with Paul.
- (2) Paul was in the Emergency Room at BroMenn when I was notified that I had been nominated Fairbury's Citizen of the Year. Paul really wanted to be with me at this event, so I checked with Heritage about getting their van to take Paul to Fairbury. They agreed and Paul got to see some Fairbury friends that evening. That was in June. (Paul had fractured a vertebra in his back and was not mobile.)
- (3) We celebrated our 50th Wedding Anniversary in August at ISU Hancock Stadium (a few blocks from Heritage Health in Normal). Some of my Alpha Beta sisters and their spouses were able to share this party with us. Our daughter, Janet is a great party planner.
- (4) Paul was back in the hospital in December with a jaw infection. I prayed that he would be able to celebrate Christmas with the family. Everyone was coming home again from Texas, Missouri, and northern Illinois to celebrate Christmas on December 27. We did have our Christmas party in the Warner Lounge at Heritage Health. We shared oplatek (a Polish custom), opened gifts, took pictures, and had a great time. Paul picked out the Christmas card for me and my necklace. Great memories!

ABC UPDATE

Affordable Care Act Form 1095-B

New this year is Form 1095-B needed to prove to IRS that you have health insurance. The FAQ below is excerpted from the State of Illinois website of CMS for retirees who receive their health insurance through TRIP or TRAIL—

What is Form 1095-B? Why do we need one?

The Affordable Care Act is a federal law that requires almost everyone in the United States to have medical coverage. The law stipulates that beginning in tax year 2015, people who don't have at least a minimal level of coverage could have to pay a fine to the Internal Revenue Service (IRS). When filing taxes in 2016, most people will have to report to the federal government whether they, along with their covered dependents, had medical insurance coverage during the previous year.

Form 1095-B is a tax form (like a W-2 or 1099-R) that you will receive from your Teachers' Retirement System Program (TRIP) medical coverage provider as proof that you and your covered dependents had the required medical coverage during 2015.

What do I do with my Form 1095-B?

You will use Form 1095-B to verify medical coverage for yourself and your covered dependents on your federal income tax filing, much like you use your W-2 to report wages or your 1099-R to report annuity income. Receiving Form 1095-B does not mean you owe income taxes on the value of the healthcare benefits you receive. You should keep your Form 1095-B with all your tax records as supporting documentation.

Who will get Form 1095-B?

TRIP members who were enrolled in the Quality Care Health Plan (QCHP), HealthLink OAP, Coventry OAP, Health Alliance HMO, Coventry HMO, HMO Illinois, or BlueAdvantage HMO sometime during the year, will receive a 1095-B form. Retirees and Survivors enrolled in a Medicare Advantage plan offered through the TRIP Total Retiree Advantage Illinois (TRAIL) Program will not receive a Form 1095-B from the individual plans or from CMS. Individuals enrolled in a TRAIL plan may receive Form 1095-B from the Federal Centers for Medicare and Medicaid Services.
